Meeting called to order by Darrel Jones at 6:11 p.m.

Items discussed:

<u>General Office Matters</u> – rain check forms for Young Eagles in briefcase; Paul Siebert recovering from Oshkosh; BK's will not be present for Young Eagles in September and his computer is currently down (no email).

<u>Articles of Incorporation</u> - need to obtain duplicate from CA Secretary of State for filing of non-profit documents with attorney. Fee \$250 for services. Will also file a 990 with tax return.

EIN (inactive) 68-0437795 Non-stock / Non-profit corporation.

Binders - Organization regarding Bylaws; Standard Operating Procedures; Officers' duties. CD will also include records, correspondence, newsletters for ease in administration transitions. Hanging folders for files will be used. Swivel wheels will be installed on file cabinets to prevent water damage and for easy relocation.

Q: Do Articles of Incorporation exist? Marsi to obtain copy from CA Secretary of State.

Treasurer's Request Regarding Deposits:

Treasurer to convert deposit of cash from meetings into check for ease of funds handling.

Scholarship Information: Information will be downloaded and advertised with community / chapter for sponsorship of Air Academy - - will solicit "letters from applicants" requesting scholarship. Currently nine slots available in the various age categories. We need to determine source and levels of sponsorship. Advertisement to begin October for delegation of spots. Air Academy Deadlines: FEBRUARY-24, 2011 – Deadline for All Paperwork from substitutes FEBRUARY 28-2011, Application from interested kids MARCH-31-2011, for refunds + points to Mary in Wisconsin

- Q: What if kids who are selected for Air Academy decide not to attend at last minute -- what's the cut-off for slotting in someone else? FEB-24-2011
- Q: What's are sponsorship allotment? It costs approximately \$1,500 net for meals and donations. We (treasure) have approximately \$8,000; we should set a reserve of \$5K. We need to solicit donations for scholarships.
- Q: If we are asking for Donations, what do we need material, do we have any? We have a video and literature. We are also a 501 non-profit status which gives us opportunity to provide a "donation /

charitable letter." We should include the Saturday burger funds.

9 slots / 3 per group – cost for Air Academy approx. \$1100/\$870/4680

Flight: \$381 per child, round trip. Fly into Minneapolis and into Appleton.

Equipment for Family Fun Day – Martin's parents are involved with selling ice cream and popcorn. They have a cotton candy and hot dog machine if anyone is interested.
