#### EAA 1268 MEMBERSHIP CHAIRMAN AND TREASURER REPORT 2016

**Membership Report** – I'm happy to report that our membership is maintaining its strength in numbers and also in dues accountability. With 72 members considered active (have paid dues within the last 2 years), 41 of them have paid dues for 2016.

Twenty-one who were current in 2015 still have to pay, and we have 10 members who were last active in 2014. For you new members [and those of us old(er) with memory problems], the clue as to whether you're current is your badge color – blue if current, white if not. If you have no badge it means you've been dropped from the roster which happens after 2 years delinquency.

**Treasurer Report** As I mentioned in my brief oral report to the membership at last month's meeting, the state of the treasury is in good shape – to be more specific, our checking account balance on December 31, 2015 was \$189.86 greater than on December 31, 2014. Some of the categories of credit were: Member dues - \$745, Air Academy donations - \$1500, excess dinner receipts - \$311.87. Some categories of debit were: EAA national -\$455 (insurance) and \$1565 (Air Academy tuition), and website hosting - \$125.88. I sent a more complete accounting to all of the board members last month. If any member would like the same accounting let me know and you'll get it by email. ## A PERSONAL "EDITORIAL"

I am hesitant to visit this issue in the newsletter, but want everyone reading this to understand that the following is my personal opinion and does not represent the opinion of the officers, board members or other members of Chapter 1268. I feel it is enough of an important issue that it should be discussed at the meeting.

I also wholeheartedly support the mission of the EAA and have great respect for those persons within the organization working so hard to preserve and protect our right to fly.

The following is an email I sent to Jack Pelton and the Directors of the EAA:

## Dear Jack,

I have been volunteering for many years with the EAA Young Eagles program, but am very upset that I may no longer be able to do so unless I submit my Social Security number and personal information and submit to a criminal background check. Further, I understand that I will be compelled to sign a waiver holding EAA and its contractor harmless should my Social Security number and personal information be stolen and I suffer financial loss. Police are routinely able to do a check of individuals without requiring their Social Security number. You have my permission to conduct such a background check without using my Social Security number and without my having signed the hold-harmless waiver.

I am deeply disturbed that EAA has succumbed to the hysteria surrounding the potential for registered sexual predators harming the youth we serve. Unless someone has already committed such a crime, a criminal background check serves no purpose. On the other hand, all credit security agencies strongly caution against giving out such information due to the much more common crime of identity theft and credit fraud.

I strongly urge you to reconsider what I feel is an unnecessary intrusion into our privacy. I volunteered as a CPR and first aid instructor for the American Red Cross for 38 years until they also enacted criminal background checks for their volunteers. I could not continue to do so without giving up my confidential information and also signing a waiver relieving them of any responsibility for any compromise of that information.

I hope I will not also need to stop volunteering with the EAA for this same reason.

I would appreciate it if you would forward this to the rest of the Board of Directors. I am sure that I am not the only EAA volunteer upset by this new requirement.
